Text Messaging Contest Rules and Information

GRAND PRIZE INFORMATION:

1. One lucky winner will be awarded a grand prize – a minimum of (2) two tickets to Stanislaus County Fair's always sold-out event – Destruction Derby I Traditional Turmoil, on Monday, Aug. 3, 2009.
2. WIN TEN TICKETS INSTEAD OF TWO! Text club members are encouraged to invite their friends to become members of the StanCoFair Mobile Text Club. If the Mobile Text Club membership number surpasses 5,000 by the contest deadline, then the grand prize winner will receive (8) eight additional Destruction Derby I Traditional Turmoil tickets – totaling (10) ten Destruction Derby I Traditional Turmoil tickets. Fair admission will be included with the winning tickets.

HOW TO ENTER:

1. Text "DERBY" to 47645.
2. You will be invited to join StanCoFair Mobile Text Club. You must be a member of the Mobile Text Club to win this contest.
3. There is a maximum of 5 entries per day per cell phone number.
4. Encourage all of your friends to text "DERBY" to 47645. The more friends who become members of the Mobile Text Club, the higher the chances are of you winning (10) ten Destruction Derby I tickets instead of (2) two!
5. Contest ends at 11:55 p.m. on April 30, 2009.
6. The text messaging software will randomly choose a winner from the DERBY contest membership entries. A text message will be sent to all who participated to thank them for entering. A text message will be sent to the winner to notify them of their prize.
7. The winner must call the phone number that will be provided in their winning notification text message, to verify his/her cell number, first and last name and age.

HOW TO CLAIM WINNING TICKETS:

1. The winner shall pick up the grand prize tickets from the Ticket Office at the Stanislaus County Fair, 900 North Broadway, Turlock, CA 95380, during regular Ticket Office business hours. Hours are 8:30 a.m. to 4 p.m. Monday through Friday, beginning May 4, 2009.
2. The winner must provide identification when retrieving the tickets. Proper identification includes: state issued identification card and/or state issued driver's license. The winner must provide the cell phone with the winning message displayed.
3. The winner will have until close of business on May 15, 2009 to pick up the tickets.
4. If the tickets are not picked up by the specified date, the winner forfeits the tickets. A second winner will then be chosen from the remaining entries at random by the text messaging software.
5. If the winner is under the age of 18, a minor, and does not have proper identification a legal guardian must be present when claiming the tickets. The legal guardian must fill out and present an identification form to provide proof of the minor's identity. The form will be sent to the winner through email or fax.
6. All fair employees and their immediate family members are excluded from participating.
